Deems Desirable

On August 27, 2007 the union communicated with the postal service at the HQ level and sought answers to many questions regarding Deems Desirable.

The Union requested the position of the postal service as to the instances when a supervisor could request medical for under three days.

It was the position of the union that an employee must either be on restricted sick leave or the supervisor deemed the documentation for the protection of the postal service. The supervisor couldn't simply place the employee on deemed desirable because they had a poor attendance record.

On September 10, 2007 the postal service responded and stated "As far as the Postal Service is concerned, there is no dispute or disagreement regarding the conditions under which an employee may be required to submit medical documentation or other acceptable evidence for periods of absence of 3 days or less"

The issue of deems desirable has become a problem for our members. Any employee who has been placed on the deems desirable and has an absence of

less than 3 days, should contact a shop steward and file a grievance.

The burden shifts to your supervisor to provide the rationale of why you were placed on the Deems Desirable list. In many cases your supervisor hasn't placed you on the list, upper management has.

FMLA—2 Business Days

The local has filed a class action grievance on management's failure to respond to request for FMLA protection within 2 business days. We have gone back and looked at past instances where employees weren't provided with a response and a grievance was justified.

We are asking all employees who don't receive a timely response to contact their shop steward. To show there wasn't a timely response please make sure you submit a PS Form 3971 for each absence and keep a copy of your 3971.

Can't Do It Without You

We can't protect craft work without you. We need our members to write statements each time you observe someone performing your work.

Each hour a rural carrier or supervisor works in your office is taken off the budget for next year. Enough hours saved could result in the loss of a full-time position. It could be your position? We need your help.

We need custodians to write statements each time they are directed to deliver mail to the hub or deliver express mail. Management intends on reducing our custodial staffing and when they can show that you spend part of your day on something else, you make it easy on them.
